 "Grass should be mowed at proper height: fescue 2-3 inches, hybrid

- bermuda and zoysia grass at 0.5-1.5 inches.
- Driveway and curbs should be edged.
- Shrubbery should not obscure windows.
- Some color from flowers is desirable."

ZONING ALERT - A developer has applied to the County to 1) amend the Land Use Plan on the southeast side of Interstate 85 Access Road, 579 feet northeast of Shallowford Road, 2) to rezone the property for the construction of apartments. The property has frontage of 483 feet and contains 13.125 acres. The application is conditional on redevelopment of the property for an apartment complex of 356 units based on a site plan. This property was most recently occupied by the Internal

Revenue Service. Long-time residents will remember when the current building housed the GEX discount store. The Hawthorne Civic Association (serving residents across I-85 from DECA) is adamantly opposed to the approval of this application and seeks the help of DECA residents in achieving that objective. The property is located in regular District 2 and Superdistrict 6 served, respectively, by Commissioners Walldorff and Yates. ## Damage Inflicted at Appling Place

Residents of Appling Heights and Marlin Acres have no doubt noticed the extensive damage that was inflicted on one of the brick walls flanking Appling Place, the short segment of pavement between Appling Drive and Appling Way that connects the I-85 Southbound Access road to Dresden Drive.

Apparently the wall was hit by a large vehicle. The cut-through is referred to as "The Entrance" by Appling Heights and Marlin Acres residents, many of whom use it to enter and leave their

neighborhoods. The brick walls at the entrance have stood for close to forty years, and up until a couple of years ago, had escaped damage, either accidental or intentional. Two previous incidents left the east wall with relative minor damage that was repaired by residents of Appling Heights and Marlin Acres. The apparent extent of the current damage suggests that major repair work will be required to restore the structure. ## Ticketing Enforcement Campaign

On Wednesday, February 5, during morning hours, Dresden Drive and Shallowford Road, in the vicinity of Dresden Elementary School, were targets of a campaign to ticket speeding drivers. During the hour and fifteen minutes that the campaign was in progress, the six DeKalb County Police Officers assigned to the campaign wrote 26 citations: 14 on Dresden Drive and 12 on Shallowford Road. The highest speed observed was 48 miles per hour. Ms. Janet Weisman, Coordinator, Safe Kids of DeKalb, was responsible for making the campaign possible. Ms. Weisman states that credit is due DECA resident Juliette Mansour for getting the job done sooner than later. "Juliette's tenacity was the key to the speedy implementation of the campaign," Ms. Weisman said. Juliette Mansour, who lives on Dresden Drive, has to deal with speeding motorists along her street on a daily basis. Kudos to Juliette who, out of concern for her own safety and that of her neighbors and the students of Dresden Elementary School

presented a convincing case to the appropriate authorities.

#### Dresden Park Renovation Ahead

You may have noticed a boarded-up former apartment building on Dresden Drive next to the entrance to Dresden Park. The building, which was purchased by DeKalb County, will be razed as part of the planned renovation of the park. Cheryl Von Soosten, DECA's liaison person for Dresden Park issues, reports that dialogue continues between DeKalb County's Parks & Recreation Department and St. Pius X High School relative to a proposed cooperative project in which the school would use portions of the park in its athletic program and assume some of the maintenance responsibilities. #### - GARDENING TIPS -

DECA's Master Gardner, Jim Dorsey, offers these gardening tips.

- February and April are the correct times to fertilized fescue with any lawn fertilizer.
- Fescue should NOT be fertilized in the summer because the roots cannot support the extra growth and also, it will require more mowing.
- Warm season grasses such as bermuda, zoysia, centipede and St. Augustine should be fertilized when 50% green, which will be sometime in May.
- It will not do any damage to the yard if the mowed grass is left on the yard as long as no more that one-third of the grass is cut.
- Now is the time to remove old foliage from liriope (monkey grass).
- Pre-emergent treatment may be spread on the lawn in March to prevent summer weeds like crabgrass. However, if you plan to put out grass seed <u>do not</u> spread pre-emergent as it will prevent grass from sprouting.

#### Meeting with Commissioner Gale

Waldorff (from Jim Griesmer, Immaculate Heart of Mary (IHM) ABLE Ministry)

A meeting with Commissioner Gale Waldroff took place on February 13 and lasted one hour. Representing the IHM ABLE Ministry were Nikki Van Der Grinten, Susan De Pasquale and Jim Griesmer. Also present was Cheryl Von Soosten representing the Dresden East Civic Association (DECA).

Commissioner Walldroff was asked to discuss the funding situation with respect to sidewalks and other pedestrian safety measures. She explained her vote against the use of additional Host funds for infrastructure improvements by saying that

she felt that the higher property tax bills which will result will be a heavy burden on home owners in these difficult economic times. Her strategy for sidewalks remains that of using county money for improvements along interior streets, while seeking federal and state funding for improvements along major streets and highways. She said she has held discussions with Congresswoman Denise Majette about the Buford Highway corridor and its pedestrian safety needs, and cited the presence of a lobbyist for the County of Washington, Patty Daley. The sidewalk projects that have been recently completed, or are underway, in Commissioner Walldroff's district include Fair Oaks, University Drive, Shady Valley, Biltmore, and Sheridan Road. She then asked for our input on additional sidewalk needs. Susan De Pasqule presented a multi-page document, including pictures, to show the need for the completion of a sidewalk along a six-tenths of a mile stretch of Frazier Road, between LaVista Road, past the railroad tracks, to Springbrook Drive. Nikki Van Der Grinten provided a picture and map showing the need for a sidewalk along the eastern boundary of the Fiesta Mall. Nikki also presented a list of several ordinances, which were unclear, or not being observed, with respect to such matters as property upkeep, asking that they be looked at. Cheryl Von Soosten asked about the status of Dresden Park. Commissioner Walldorff said that three houses had been purchased and would be demolished to provide a better entrance to the Park and that the County was partnering with St. Pius X High School on improvements to the Park. Commissioner Walldorff also talked about a green space acquisition of 20 acres south of the PDK Airport on which the houses have been taken down. She also discussed in the general issues surrounding the airport with the hope that these could be worked out by all the parties concerned. Finally, Jim Griesmer bought up the subject of visitation at the DeKalb County Jail, a matter raised by the Hispanic community at the previous IHM parish assembly. Commissioner Walldroff said that the Commissioners' hands were tied in that,

DECA received the following message from DeKalb County State Court Judge Johnny Panos on February 19, 2003.

I have put together a Public Informational Forum for Thursday, April 10, 2003, starting a 6:00 p.m. at the Maloof Building (in downtown Decatur).

Commissioners Walker and Johnson and Gwen Keyes will assist me in putting on the program "Domestic Violence, What you should know and What to do about it." This program will be an informational and how-to forum. Please spread the word around and especially in the churches and communities. At the present time the program will have a Superior court Judge talk about *How to get Temporary* Protective Orders. We will have individuals from Women's shelters and Men Stopping Violence talk about how to seek help. We will have Solicitor Keyes talk about what evidence is needed to make a case and any new legislation that has passed the General Assembly and we will have Chief Magistrate Winston Bethal talk about the new domestic violence arraignment program he wants to start.

Please, Please, Please spread the word around to the various DeKalb County Civic Coalition Members, parent-student council members, schools and/or principals and everyone else you can think of, I would think that this program would be insightful to all and especially school personnel. I am not sure to what extent school personnel are knowledgeable about the issues of Domestic Violence.
